



Young Volunteer of the Year Nomination Guidelines

Celebration of Philanthropy 2020

Purpose: Award presented annually to a student, elementary school through college age with a proven record of volunteerism that, through their donations of time and talent has played a key role in helping local nonprofit organizations provide services to the community.

Examples of relevant activities include tutoring, mentoring, designing social media tools for nonprofits, raising funds or goods (food, clothing, toys, etc.) for a homeless shelter, performing a public service to help build a playground, renovate housing, clean up a waterway, etc.

Nomination Form: The form must be completed in its entirety for the nomination to be eligible. Individual may not self-nominate or be nominated by a parent.

Nomination Process:

- ✦ Nominees will receive a recognition letter from CFAAC upon receipt of the nomination form. The letter will include information on the nomination and selection process.
- ✦ At a meeting hosted by CFAAC, past recipients of the Celebration of Philanthropy Awards will review the nominations and select the 2020 recipients.
- ✦ Following the selection and prior to the public announcement, all nominees and the nonprofits who nominated them will receive a letter notifying them of the results.

Criteria: Each nominee will be scored by the selection committee based upon the responses to the four criteria listed below.

1. Volunteer activities in Anne Arundel County (30 points)
2. Originality and uniqueness of the approach used in a volunteer project or activity (20 points)
3. Impact of volunteer efforts (20 points)
4. Leadership and motivation of other nonprofit volunteers (30 points)

Nomination Narrative: Provide a written statement up to 350 words for each response. The narrative should include specific information, evidence, and provide clear examples of what makes your nominee so exceptional. Nomination's may include no more than three supporting documents. Please note that the selection committee is made up of past recipients of the Celebration of Philanthropy Awards.

Be thorough in including all organizations that benefit from the nominee's support. This will enable the selection committee to fully understand the nominee's involvement in the community and breadth of impact. The best way to ensure that you have included everything is by asking your nominee for input!

How to Write a Winning Nomination

- Share the big picture – collaborate with other individuals and organizations to tell your nominee's story.
- Determine who can write the best letters of support.
- Talk with your nominee, their family, and friends. Collect as much information as possible.
