MESSAGE FROM CFAAC LEADERSHIP

During the Community Foundation's 25th anniversary year, we had a lot to celebrate. In 2023, CFAAC achieved unprecedented milestones including opening a record number of funds, distributing a remarkable amount of grants, and organizing a total of 27 educational programs. These accomplishments were made possible through the committed efforts of our supporters, staff, and board members.

The collective impact of our organization is a testament to the unwavering support we receive from individuals and organizations like you who share our commitment to making a positive difference in Anne Arundel County. Your generosity and dedication have allowed us to expand our reach and address critical needs in our community.

Thanks to you, in 2023, we were able to distribute 657 grants to vital nonprofits, totaling more than \$6.5 million, making a tangible difference in Anne Arundel County and beyond. These grants have empowered initiatives, contributed to the wellbeing of our community, and provided the resources needed to make a meaningful impact.

We also opened a record number of funds—40 total—largely thanks to our Nonprofit Endowment Fund Special Offer to nonprofits. In addition to newly established Donor Advised and Legacy Funds, we opened 22 Nonprofit Designated and Endowed Funds. This trend continues to gain momentum in 2024 as additional nonprofits are opening funds and more than 79 nonprofits have reached out to our team expressing interest in establishing a new fund with CFAAC. All totaled, 38 Nonprofit Agency Endowment Funds were opened during CFAAC's 25th Anniversary promotion, which ended on May 31, 2024.

CFAAC also saw some staff changes—we sadly said goodbye to our Director of Development Damika Baker-Wilson who joined us in our journey as we planned for our 25th anniversary celebration and who skillfully steered us through two Celebration of Philanthropy events. On a wonderful note, we welcomed three staff members— John Rodenhausen joined us in February as our Director of Gift Planning, Jennifer Lagrotteria joined us in October as our Director of Philanthropic Resources, and Camille Kalb joined us most recently in December as our Philanthropic Services Associate. All have years of experience that will enhance our team.

We also said goodbye to board members who were instrumental in helping us achieve our goals throughout the years. They remain as a significant component of CFAAC's narrative and we deeply appreciate the support, contributions, and expertise they offered during their years of service. Thank you Anne Hamel, David Irving, and John Rosso for your service. In 2024, we welcomed two new members—Marguerite (Marcie) Keane Gibbons and Crystal Watkins Williams—to our board. We are excited to work with and learn from them.

As we look ahead, we continue to be filled with hope and optimism. Our collective strength is great. By continuing to work together, the ripples of doing good will flow through our community, helping us to fulfill unmet needs, foster collaboration, strengthen nonprofits, and make life better for everyone in our county.

Helping you make the most of your generosity is what the Community Foundation of Anne Arundel County is all about. Since 1998, we have worked alongside our donors to create transformative change in our county. Thank you for being an essential part of CFAAC. 

Recognizing this, CFAAC's Fund for Anne Arundel (FFAA) has, over the past five years, focused its grants on nonprofits that prioritize the physical, mental, and behavioral health of children and families.

Since its inception, the FFAA has raised more than \$2 million, with half of this amount placed into the fund's endowment to ensure ongoing grantmaking power. This strategic growth means the FFAA's impact is continuously expanding as more community members come together to support it.

In 2023, CFAAC distributed nine grants totaling \$233,556 through the FFAA. These grants were awarded to a diverse group of nonprofits dedicated to improving the lives of children and families in our community. The 2023 grant recipients included Annapolis Maritime Museum & Park, Anne Arundel County Food Bank, Charting Careers, Inc., Chesapeake Arts Center, HOPE For All, Services From the Heart, Severna Park Community Center, Start The Adventure In Reading (STAIR) - Annapolis, Inc., and The Complete Player Charity. These organizations work tirelessly to support our community, from providing essential services like food and shelter to offering educational programs and fostering creative expression. Through the collective efforts of our donors and partners, the FFAA is making a tangible difference, ensuring a brighter, safer future for every child in Anne Arundel County.

INSPIRING PHILANTHROPY: MATHIAS FAMILY LEADS BY EXAMPLE WITH ACTIVE VOLUNTEERING AND DONATIONS

Tanya and Dan Mathias didn't receive formal lessons in philanthropy but they inherited something far more profound: a legacy of giving back from their parents.

"Philanthropy wasn't actively taught to either of us, but we both observed our parents volunteering in different capacities and participating in various community organizations throughout the years," Tanya reflected.

Their upbringing laid the foundation for their own journey into the world of giving back. Part of that journey was their introduction to the Community Foundation of Anne Arundel County. It was a pivotal moment, according to Dan, a licensed Fire Protection Engineer. "When we initially sat down with Mary [Spencer] to learn about the Community Foundation, we gained an understanding and clear perspective of what the organization really stands for in our community," he said.

They were impressed by the relationships and the amount of support the Community Foundation provides to local businesses, charities, and other organizations. They were also impressed by CFAAC's thorough community needs assessment and how CFAAC identifies nonprofits to fill the needs. It led them to opening the Mathias Family Foundation, a Donor Advised Fund in 2021, and Dan becoming a CFAAC Board of Trustees member in 2023.

As parents to two boys, ages 13 and 11, Tanya and Dan were intentional about instilling the importance of philanthropy from a young age. They involve their children in conversations and activities as much as they can to demonstrate that even small efforts can yield significant impacts. "Giving together and supporting each other's efforts with the work that we do is a big priority and extremely fulfilling for us as a couple and as a family," said Tanya, who has a marketing background.

Their commitment to giving extends beyond financial contributions. Dan has served on several community boards and coached their son's baseball team, and both parents actively volunteer at their children's school. For Tanya, serving on the school's board of directors, sitting on various committees, and being involved with the PTA are meaningful ways to contribute. "I love being active in our boys' school," she said.

In their eyes, the Community Foundation serves as an invaluable ally on their philanthropic journey. As Fund Holders they feel that their contributions are being stewarded in a professional way that offers security for the future. "Simply put, the Community Foundation is an amazing organization led by trustworthy custodians who put donated dollars to good work in support of local charities and philanthropies," said Dan. "They have acted as a gateway and advisor for giving in our community. And they make giving easy through their platform."

Through their partnership with CFAAC, Tanya and Dan have learned that giving has no bounds. "No matter how big or small, there are all kinds of ways to make an impact with giving," said Tanya. "The Community Foundation can help anyone start that process."

EMPOWERING POTENTIAL: ZETA GAMMA BOULÉ AIMS TO TRANSFORM YOUNG LIVES

Zeta Gamma, the Anne Arundel County and Annapolis boulé of Sigma Pi Phi, wants to change the life trajectory of young African American men and women in Anne Arundel County (AAC). Founded in 2021 as part of the fraternity, Zeta Gamma's mission is to create positive change in the community and to help young African Americans to become successful through college education and mentorship. Sigma Pi Phi is recognized as the first African-American Greek-lettered fraternity and was founded on May 15, 1904 in Philadelphia, Pennsylvania, by six African-American professionals "of refinement, unquestioned integrity and notable achievement." It has more than 5,000 members and over 135 member boulés (chapters) nationally and internationally.

The Zeta Gamma boulé has already implemented one of its social action objectives, which is to mentor county African American high school students and help them prepare for the SAT exams, said Aris T. Allen, Jr., Zeta Gamma's Charter President.

"We recognized that Anne Arundel County (AAC) is way below the national average for SAT scores," said Aris, who became involved with the Sigma Pi Phi Fraternity through his dad. "So we focused on helping students learn techniques and skills to effectively take the exam. We want to try and raise the statistics for Anne Arundel County."

Last summer, 12 students spent four hours every Saturday morning learning from testing experts. The instructors focused on test-taking techniques, time management, and other skills. At the end of each SAT prep session, Zeta Gamma provided lunch and members of the boulé, professional men ranging in age from 40-80 years, spoke to the students about their respective careers, which included healthcare, law, business, education, and architecture.

"The students had an opportunity to learn about different professions and to interact with professionals who they can identify with," said Aris. "Many of these students aren't normally exposed to this. It's a way to get them to see what the possibilities might be for them."

This social action program also provided transportation to several college fairs where the students met and talked to college representatives. They learned about the entrance application process and requirements. Many of the students received college acceptances.

This summer, Zeta Gamma is continuing the SAT prep and mentor program along with a few fun activities such as a bus trip to New York City to see the Broadway hit, "The Wiz." They are planning to offer additional activities during the 2024-2025 school year.

Zeta Gamma also aims to establish a college scholarship program for African American students. With the help of a generous donor, Zeta Gamma established a Foundation and a Donor Advised Fund with the Community Foundation.

Aris is optimistic that they can help students who could otherwise not afford college: "We are looking forward to a long-term relationship with the Community Foundation of Anne Arundel County whose programs and fundraising have been beneficial to various community initiatives."

GIVING HOPE: THE BLUE RIBBON PROJECT OFFERS FOSTER CHILDREN A COMMUNITY

Brightly colored backpacks and clear bins of meticulously organized clothing and supplies line the shelves at The Blue Ribbon Project, located on the old Crownsville Hospital campus. However, this space holds more than clothing and necessities, it holds hope and a little bit of normalcy for area foster children.

The Blue Ribbon Project (BRP) founder, Taylor Pyles, could have had a very different life. As a victim of child abuse, he was in foster care until he aged out. Witnessing peers succumb to destructive behaviors during their teenage years, Taylor chose a different path. As the executive director of BRP, a nonprofit that supports victims of child abuse and neglect, youth in foster care, and adult survivors of child abuse, Taylor has helped thousands of children and adults over the past 12 years.

Initially, Taylor established BRP as a website to support adult survivors of abuse. However, after reflecting on his own experience of being sent to foster homes with just the clothes on his back, he felt compelled to contribute in a more tangible way. While working as an Annapolis Police Department Detective with the Criminal Investigations Division, Taylor began assembling backpacks containing essential items tailored to the recipients' age and gender, including toiletries, clothing, and books at his home. He stored them wherever he could, including a spare bedroom. These backpacks were then distributed to the children, ages one month-18 years, who were in the foster care system. Since retired, Taylor now volunteers full-time at BRP and during their last fiscal year, more than 600 children received these "Backpacks of Love."

Since its inception, the organization has grown, encompassing not only Anne Arundel County but also 13 other Maryland counties as well as Baltimore city. It is now working to expand to two other counties on the Eastern Shore. "We went from backpacks in a bedroom to a 5,000 square foot building," said Taylor, reflecting on BRP's growth. "It's not what I expected to happen; you kind of just hang on and go for the ride."

The backpacks represent only a fraction of the organization's broader community programs. BRP programs also include many training courses including Aging Up...Not Out, a life-skills program for older foster kids; Celebrations Club, a program to celebrate foster children's birthdays and other special events; and

Mirah's Closet, a place where foster children and parents can "shop free" for essential items such as clothing. Thanks to CFAAC grants, Mirah's Closet has tripled in size over the past three years. "The most recent CFAAC grant allowed us to double the infrastructure, enabling us to get more storage space and carry more stuff, which allows us to better serve the children," said Taylor.

Amidst the dedicated efforts of and programs at BRP, members of a local quilting club passionately craft dozens of quilts each month. These meticulously made quilts serve as more than just blankets; they often provide solace for children navigating the upheaval of being removed from their abusive homes, often in the middle of the night.

"We've grown so much and the volunteers, community, and CFAAC have helped in so many ways," said Taylor, who noted that the BRP is an all-volunteer organization. "We just couldn't do what we do without our volunteers."

BRP's growth stirred thoughts about the future and the foster children who continue to come through the system, and that's the main reason why Taylor established The Blue Ribbon Project Fund, a Designated Fund at CFAAC. With the help of donors, The Blue Ribbon Project intends to grow it into a permanent Endowment Fund to create the kind of lasting impact that is so important to their mission.

"I want to make sure Blue Ribbon stays around even when I'm gone," Taylor said. "I want to continue to grow it with CFAAC; I look at it as a partnership."

And to other nonprofits who are thinking about opening an endowment through CFAAC, Taylor said, "Definitely go for it-open a fund; you will see the growth and who knows what a couple years will bring when it comes to donations."

SUPPORTING GROWTH: MARYLAND HALL STAYS ROOTED WHILE Embracing the future

An artistic symphony unfolds within the corridors of Maryland Hall – it's a choreography of sound, movement, and creativity where the cadence of instructors guiding students, the delicate strings of violins, the rhythmic footsteps of dancers, and the percussive sound of potters shaping clay echo through the air.

If you live in or have visited Annapolis, you may have attended a performance, a gallery opening, or even taken a class at Maryland Hall. As it so eloquently states on its website, "Dedicated to Art for All, Maryland Hall stands as the region's cultural core, actively convening and engaging people of all ages and backgrounds in arts experiences that strengthen community."

To Maryland Hall Executive Director Jackie Coleman, it's a place that fosters connectiveness and expression. "Maryland Hall has a powerful ability to make connections happen on a lot of different levels through our art classes, performances, and galleries."

Knowing that they wanted this hub of creativity to flourish and continue to build community, Jackie and the Maryland Hall board of directors jumped at the chance to open the Maryland Hall Endowment Fund during the Community Foundation's 25th Anniversary Nonprofit Endowment Special Offer.

"It was really exciting to participate in the Community Foundation's anniversary initiative and this helped the board make a decision quickly; they wanted to be a part of it," Jackie said. "They saw the importance of being able to have and grow sustainable funds that can help if there is a rough time. Also, there's only so many hours in the day and the administrative help that the Community Foundation offers—managing an endowment—is a plus. It takes the administrative work off our plate."

Generating awareness of Maryland Hall was also on leadership's mind when they opened the fund, and she emphasized the opportunity for contributions for the new fund. "The Community Foundation is a voice for nonprofits and having them represent us meant a lot to the board," she said.

"My experience with Annapolis is that it is very network focused and intertwined in a really positive way," continued Jackie. "On that note, the Community Foundation gives us a great opportunity to plug into this interwoven network."

There's no mistake in saying that Maryland Hall has grown over the years and it continues to do so. One example is the organization's newest addition—the Media Arts Hub.

The Hub is a destination for creatives to learn, create, and express themselves through graphic design, digital illustration, animation, music/audio production, photography, and video production.

"The Media Arts Hub represents the way we are growing—moving to a new way of presenting arts," she said. "We are trying to align to where the world is going while staying grounded in a building that is 132 years old. It's an opportunity to keep the roots but change and grow into the future."

"So alongside building the funds, we are trying to be thoughtful about the programming, growing with our community's desires and interests," she added. "In the same way that endowments can help sustain us, they can help us grow."

MAINTAINING HISTORY: HISTORIC LONDON TOWN AND GARDEN'S ENDOWMENT FUND ENSURES ITS FUTURE/PRESERVES ITS PAST

Mickey Love wants to share a secret. As Historic London Town and Gardens Executive Director, she believes that more local people should discover this "lost" colonial town and garden sanctuary on the South River. Mickey describes Historic London Town and Gardens as not only a place of history but also a place of refuge and "a place to take a breath."

Spread across 23 acres, London Town offers a blend of meticulously tended gardens; a rich, historical narrative dating back to its establishment in 1683; and a venue for weddings, even welcoming four-legged companions.

Initially the county seat of Anne Arundel County, London Town thrived for a century, until changes in trade routes led to its decline. The sole surviving historical building, the William Brown House, once served as the county Almshouse until 1965. Recently, London Town was designated a Site of Memory by the UNESCO Slave Route Project.

"We want to honor and recognize the lives of those slaves. We also want to tell the story of the ordinary, everyday people who lived here when it was a thriving port" said Mickey.

Recognizing the obligation of caring for such a historic property, Mickey and the board understood the need for financial stability amid economic instability and varying grant availability so they established the London Town Foundation Endowment Fund at CFAAC. The endowment serves as a commitment to preserving the stories of those who lived and worked here, ensuring a continuous income stream for the organization.

"There's a tremendous responsibility when you're taking care of historic property; we are maintaining history," explained Mickey. "We want to be good stewards of this property. For us, an endowment says to others, 'we are going to be here; we're not going away. We take our commitment seriously."

Mickey said there were very lean periods at London Town and the board was looking for ways to make sure that they were here for

future generations. When she found out about CFAAC's Special Endowment Offer, it was an easy decision.

"The whole endowment special offer was a homerun," said Mickey, referring to CFAAC's 25th anniversary endowment program for nonprofits. "I totally applaud the Community Foundation for offering this, particularly for the smaller nonprofits; it's just incredible. I am certainly not savvy on investments, and it is so important to have the security of knowing that your funds are wellmanaged, particularly for nonprofits who don't have that expertise. You don't have to worry about it. We now have people with the knowledge and experience."

"I've been with nonprofits for years and you're always pressured to have an endowment," she added. "But for small nonprofits, you don't always know what's involved with an endowment, and what you do with it. So, partnering with the Community Foundation checks the box; it's one thing you can take off your plate. The beauty of this offer is that you can even start small."

Mickey also touts the benefits of generating awareness for London Town through CFAAC. "We want people to know about London Town beyond the 25 mile radius. We don't have a huge staff or advertising budget so by partnering with such a reputable organization as the Community Foundation, more people will know about us."

More than anything, though, Mickey wants this hidden gem to be treasured for a long, long time: "The endowment is really about maintaining this history; it's about believing in the value of our programs and continuing the legacy. I just want people to know about this special place—this oasis of calm."

TRANSFORMING FUTURES : MDRRC GIVES HOPE TO RECENTLY INCARCERATED INDIVIDUALS

The journey from incarceration to societal reintegration is often fraught with challenges, but hope emerges in the form of the Maryland Reentry Resource Center (MDRRC). Fueled by a belief that growth and recovery hinge upon awareness and sustainability, MDRRC is a beacon of support for recently incarcerated individuals who are transitioning back into society. The nonprofit is only a small team of dedicated staff and volunteers but has ambitious goals. Thanks to community grants and partnerships, these goals don't seem insurmountable.

Through MDRRC, program participants gain access to employment opportunities through landscaping training with MDRRC's partnership with the Chesapeake Conservation Landscaping Council, a stipend of \$15.00 per hour, and free transportation. MDRRC has applied for and received previous funding from the Community Foundation of Anne Arundel County (CFAAC)—including grants from the Help Our Neighbors Fund.

"You have to have diversified funding streams to be successful," said MDRRC Executive Director Vanessa Bright, referring to why the organization applied for CFAAC's grants.

Grants from CFAAC's Help Our Neighbors Fund are focused on client assistance—buying work supplies, mental health services, food, clothing, transportation, and accessing government documentation such as IDs and birth certificates—factors that are essential for MDRRC's clients to succeed.

Another goal of MDRRC is to help reduce recidivism rates. Recidivism occurs when a released individual reoffends or repeats their crime after already having served a full sentence. According to the World Population Review, Maryland's three-year recidivism rate is currently 40.5%. To reduce that percentage, MDRRC advocates for more standardized programs across the prison system so incarcerated individuals are able to receive proper assistance in the earlier stages of transitioning to society. At this point, some have access to better reentry programs than others—while others may not have access at all.

According to Vanessa, a standard system would ensure that those who are incarcerated will have what they need along with additional training and a paid stipend for jobs that they may already have while serving their sentences. This will allow them to save for security deposits and rent for the first few months after release, as well as obtaining the proper documentation to apply for a position, and possibly provide support for any substance abuse disorders and mental health issues.

To make sure they accomplish these goals and to ensure the organization's longevity, MDRRC opened a Nonprofit Designated Fund with intent to endow—the Maryland Reentry Resource Center Fund at CFAAC.

MDRRC also wants to create more awareness about what the organization does for individuals reentering society. To accomplish that, the organization has pushed for more speaking engagements, networking, annual impact reports, quarterly newsletters, outreach, and social media. Invitations to resource events are a plus because they provide the organization the opportunity to promote the services that they offer. Opening the fund with CFAAC will also generate more awareness for the nonprofit.

"To help these new Fund Holders reach their goals, CFAAC is pleased to be able to promote their new designated or endowed funds through our social media, e-newsletter, website, and during conversations with the donors who look to us for effective nonprofits" said CFAAC Director of Gift Planning, John Rodenhausen.

"You don't know what you don't know," Vanessa said. She hopes that spreading awareness and promoting education about the barriers that incarcerated individuals face in the prison system will help the public develop a sense of compassion and reduce social stigma. Going forward, her goals for MDRRC are to offer transitional housing and add monthly support groups for men and women. Another objective is for program participants to attend driving school to obtain a license. Lastly, MDRRC is working on developing a social enterprise around their stormwater maintenance training program, partnering and sharing a contract with the city and the county to create transitional employment.

"I really hope that we [as the community] will find a way to collaborate [with each other]," Bright says. "There's enough work that needs to be done. If we work together, we can have a great impact."

RUNNING AHEAD: DAN AND SUSAN MORRISSEY PLAN TO Establish a legacy of giving

Dan and Susan Morrissey are gearing up for more than their next marathon race, they're also in the process of shaping a future defined by philanthropy. Since retirement, they've been raising funds for charities while running marathons worldwide, most recently the Tokyo Marathon in Japan.

"It's fulfilling to be part of a team," said Dan. "I'm doing what I love—traveling, running races, and raising money to help charities."

Closer to home, Dan and Susan recently established the Morrissey Legacy Family Trust with the Community Foundation so they can continue to support causes after they are gone. They became interested in the Community Foundation when Dan read about CFAAC's Special Offer for Nonprofit Endowment Funds. Dan, a board member of the South Shore Recovery Club, saw the offer as crucial to sustain the organization's mission in perpetuity.

"I got the ball rolling with the South Shore Recovery Fund and when I started to understand more about the Community Foundation, I wanted to be involved," said Dan, who with Susan, attended the Celebration of Philanthropy Awards Luncheon. They were immediately impressed with the awardees and their accomplishments. "We came away thinking, 'we ought to do something like that,'" said Dan and soon after, they contacted CFAAC about establishing a fund.

Despite humble beginnings, with Dan growing up in Chicago and Susan in Ellicott City, both were raised with a strong work ethic that guided their successful careers—Susan as a RN with Mercy Medical Center for 35 years, and Dan in the auto parts distribution business for 41 years. "We have been so fortunate in our lives so we want to help people have the same opportunities that we had," said Dan.

The Morrisseys aim to both aid those less fortunate and instill a charitable philosophy in their three adult children. "We feel it's imperative to demonstrate the importance of giving through our actions," said Dan. They are considering endowing their fund to ensure their giving continues in perpetuity. "Even after we and our children are gone, we like the idea that there will still be an impact from our legacy," said Susan, who with Dan, is impressed with the professionalism and services provided by the Community Foundation.

"I can confidently give money and know that it's going to be handled the right way," said Dan. "I truly believe that by giving back, we are going to end up sleeping better at night and feeling more fulfilled in general. I'm a big believer in what comes around, goes around, and when you help others, good things happen."

Dan and Susan said they hope people appreciate their opportunities in the U.S. and recognize that not everyone in the world gets the same opportunities. Dan added: "We hope that we can inspire other people to reach out to CFAAC and figure out how they can make an impact in the world. I learned a long time ago that money in

the bank doesn't buy happiness, but giving back does."

ARTS AND CULTURE ANNE ARUNDEL FUND

This fund enhances the vibrancy and creativity of Anne Arundel County by providing grants to nonprofits. These grants enable economically challenged individuals and families to experience and participate in various arts and cultural activities, including visual, fine, decorative, and folk arts, as well as literature and language programs. This fund makes artistic experiences accessible to all and fosters a vibrant community.



COMMUNITY CRISIS RESPONSE FUND

This fund provides flexible financial aid to local nonprofits post-community crises. During COVID-19, it disbursed nearly 300 rapid-response grants, totaling over \$2.7 million. Established after the 2018 Capital Gazette shooting, this fund supports human services, emergency assistance, health, mental health, and educational resources during critical times.



STRENGTHENING NONPROFITS FUND

This fund supports Anne Arundel County nonprofits by providing educational programs and training in fundraising, management, board development, and marketing. Over the past five years, it has facilitated over 50 programs, benefiting more than 4,200 nonprofit members and enhancing their effectiveness through essential capacity-building opportunities.



GRANTS 4 TEACHERS

This fund enables Anne Arundel County Public School educators to implement innovative projects that enrich student learning. With more than \$100,000 funded through nearly 250 projects, it empowers teachers to inspire and engage students creatively, overcoming traditional funding constraints.



FUND FOR ANNE ARUNDEL

The Fund for Anne Arundel (FFAA) aligns CFAAC's grantmaking with findings from its *Community Needs Assessment Report: Poverty Amidst Plenty VII*. Supporting nonprofits that address critical needs in Anne Arundel County, especially for children and families, it has granted more than \$750,000 through 2023. Read more about the FFAA on page 9.



HELP OUR NEIGHBORS FUND

2023 COMMUNITY EDUCATION SERIES

In 2023, the Community Foundation of Anne Arundel County hosted a series of Education Series workshops and events designed to Educate, Collaborate, and Connect the community. These sessions aimed to address the diverse needs of the community and strengthen the capacity of local nonprofits. They included community-focused discussions, nonprofit development, and leadership training, providing valuable insights and resources to tackle social, health, legal, and operational challenges.

Many of these programs were informed by the findings in CFAAC's comprehensive community needs assessment report, *Poverty Amongst Plenty VII: Moving Forward Together*. This report highlighted persistent local trends and systemic gaps that the workshops aimed to address. These efforts underscore CFAAC's commitment to fostering collaboration, addressing systemic issues, and building resilient and effective organizations.









COMMUNITY FOCUS

Understanding the Current Needs of Anne Arundel County's Hispanic/ Latino Communities

This workshop discussed social, health, legal, and immigration issues affecting Hispanic/Latino communities in Anne Arundel County. Panelists identified key concerns and highlighted available legal services.

Community Needs Assessment Presentation

A virtual presentation of the 2022 report *Poverty Amidst Plenty VII: Moving Forward Together*, aiming to initiate discussions and actions to address systemic gaps in Anne Arundel County.

NONPROFIT DEVELOPMENT

Donor Database and Financial Management Systems for Nonprofits This workshop reviewed best practices in donor tracking and evaluating CRM systems for nonprofits. *Generously sponsored by Andrew & Leslie Price.*

Grant Writing and Fundraising Readiness

This workshop provided key resources for successful fundraising and grant proposal development, including guidance on creating templates. *Co-hosted with Anne Arundel Community Development Services (ACDS), presented in-person and virtually.*

This workshop covered financial practices such as reporting, projections, and controls. *Co-hosted with ACDS, presented in-person and virtually.*

This workshop explored foundational approaches to program evaluation, including logic models and outcome-tracking tools. *Co-hosted with ACDS, presented in-person and virtually.*

Risk Management for Nonprofits

This workshop addressed financial risk, compliance, governance, and reputation management. *Generously sponsored by Andrew & Leslie Price*.

Strategic Partnership/Corporate Integration

This session offered strategies to enhance nonprofit partnerships for collective impact. *Generously sponsored by Andrew & Leslie Price.*

Strategic Planning for Nonprofits

LEADERSHIP AND GOVERNANCE

Adult Mental Health First Aid

This course taught participants how to support individuals with mental health or substance abuse issues using the ALGEE action plan, offered both in-person and virtually.
